The Big Bad Project promotes coexistence between people and wildlife through storytelling, research, and education that reshape public perception, inform decision making, and support more sustainable relationships with wild species and ecosystems.

Aerial Allies Program: The Big Bad Project supports nonlethal wildlife conflict mitigation by funding and advancing research on drone-based hazing techniques in partnership with USDA Wildlife Services. The program supports field research, data collection, and evaluation of unmanned aerial systems as deterrents to reduce livestock predation. Through financial support and program coordination, Aerial Allies contributes to evidence-based strategies that reduce conflict while minimizing harm to wildlife. During the reporting period, the organization raised 60,000 for this program; funds have been committed through a formal service agreement with USDA Wildlife Services and are drawn down by the agency as approved expenses are incurred.

Rewriting the Wild Program: The Big Bad Project is developing Rewriting the Wild, a storytelling and education program designed to reshape how wildlife, particularly predators, are portrayed and understood through narrative. The program engages students and writers in critical analysis and creative writing to challenge harmful or outdated representations and promote more accurate, coexistence-focused perspectives. The program is currently in development, with an official launch planned for 2026 to 2027. During the reporting period, pilot activities and expert consultation were conducted to refine program structure, curriculum, and delivery for greater impact. The organization was awarded 5,000 in late 2025 to support program implementation, with funds designated for use during the 2026 program year.

Community Education and Outreach: The Big Bad Project conducts community education and outreach activities to increase public understanding of wildlife and promote coexistence. These efforts include participation in community events, tabling engagements, and informal educational programming designed to engage diverse audiences. Through direct public interaction, the organization provides accessible, evidence-based information about wildlife, addresses common misconceptions, and fosters informed, responsible perspectives on human and wildlife interactions.
